FOR COMMERCIAL USE

All haulers must follow the instruction of the transfer station attendant on duty. Please see Hauler Permit policies for additional information.

	TYPES OF MATERIALS:	HOW TO DISPOSE	FEES \$10 Minimum weigh fee
WASTE	Non-Burnable Sheetrock, concrete, brick, asphalt, soil, glass, plaster, lath, fiberglass, siding (vinyl, asbestos), non friable asbestos siding, ceramic tubs, sinks, toilets and tiles	Mixed loads may go to Transfer Stations or Bristol Hill. Large loads (40 cubic yards) <i>must</i> go directly to the Bristol Hill Landfill, only.	Major Haulers: \$100 annual application, includes one vehicle \$20 per additional vehicle at time of application \$80/ton (4¢ per pound) at Transfer Stations \$52/ton (2.6¢ per pound) at Bristol Hill Landfill
	Burnable Wood and asphalt shingles	Loads may go directly to the Energy Recovery Facility (ERF) or to Bristol Hill.	Major Haulers must have an active account, and purchase a swipe card. Each card is \$10.00. \$52/ton (2.6¢ per pound) at ERF, must be burnable only
RECYCLABLE	Scrap Metal Metal sheeting, flashing, plumbing fixtures, piping, wire, aluminum, metal storm doors, re-bar	Must be separated from other waste. Any load may be brought to Transfer Stations.	No fee for scrap metal, only. Each CFC refrigerant containing unit has a \$15 fee.
ASBESTOS	Friable (Airborne) Ceiling tiles, and pipe insulation	All loads must go to Bristol Hill Landfill. Any load over a 10 wheel truck must call office for directive at 591-9200.	\$100/ton (5¢ per pound) at Bristol Hill Landfill
CLEAN WOOD	Must be 95% construction wood Minimum load of 20 cubic yard roll off or a 10 wheel dump truck. Length of material must not exceed four feet	Bring Directly to Energy Recover Facility (ERF) for approval by loading operator.	\$26/ton (1.3¢ per pound) at ERF facility only, have active permit and swipe card
SOIL	Petroleum Contaminated Soil Alternate Daily Cover (ADC)	All loads must be brought to Bristol Hill Landfill. Call office for directive at 591-9200.	\$26/ton (1.3¢ per pound)

OSWEGO COUNTY'S LOCAL LAW IS EFFECTIVE JULY 1, 2009

Oswego County Recycling and Solid Waste Local Law, Section 4, 8(a)ii “Flow Control” requires that all Construction & Demolition Debris generated or collected within Oswego County must be delivered to Oswego County Solid Waste Facilities.
