C&D materials are generated by construction, demolition and remodeling. Debris is C&D materials that are unable to be salvaged or recycled.

Wood, asphalt shingles	Sheetrock, concrete, stone, brick, asphalt, soil, glass, plaster, lath, fiberglass, siding (vinyl, asbestos), non friable asbestos shingles, ceramic tubs, sinks, toilets and tiles	
ALL SCRAD METAL MUST BE SERABATED		

ALL SCRAP METAL MUST BE SEPARATED

Metal sheeting, flashing, plumbing fixtures, piping, wire, rebar, aluminum, large metal appliances, metal storm doors and windows with no glass

OSWEGO COUNTY LOCAL LAW IS EFFECTIVE JULY 1, 2009

Oswego County Recycling and Solid Waste Local Law, Section 4, 8(a)ii "Flow Control" requires that all Construction & Demolition Debris generated or collected within Oswego County must be delivered to Oswego County Solid Waste Facilities

> All residents and haulers must follow the instruction of the transfer station attendant on duty. Please see Residential Tipping Fee and Hauler Permit policies for additional information.
