A local law Amending the Town of Granby Zoning Ordinance

Be it enacted by the Town Board of the

**SECTION I.**

Section "N" Farm Labor Camp is hereby repealed and a new Subsection "N" is hereby adopted to read in full as follows:

A Farm Labor Camp is a specially permitted use in either the "A" or "A/R" zones providing that the property on which the use is located is included in County approved, State Certified Agricultural District pursuant to Article 25AA of the Agricultural and Markets Law. The establishment of such use shall be subject to review and approval of the Planning Board pursuant to Section VIII "R" of the Ordinance.

**SECTION II.**

Section XI definitions is hereby amended by adding to the definition of billboards, the following language:

A sign shall not be considered a billboard merely by reason of its use of changeable copy (electronic or otherwise) that refers to off-site activities of a broad community or social interest.

**SECTION III.**

This Local Law shall take effect immediately upon its filing with the Secretary of State.
