A local law providing for the appointment of a sole assessor.

- From and after the first day of July, 2004, there shall be but one assessor of the Town of Granby, who shall be appointed by the Town Board pursuant to New York Real Property Tax Law section 310.
- 2. The provisions of this local law shall supercede any inconsistent law, rules and regulations.
