TOWN OF GRANBY ORGANIZATIONAL MEETING JANUARY 4, 2022 6:30 P.M.

CALL TO ORDER

Supervisor Snow, Jr. called the meeting to order at 6:33 P.M. leading those present in the Salute to the Flag. Present for the **roll call** were Supervisor John Snow, Jr., Councilors Rodney DeLong, Sandra Farrands, Marianne Ingerson and Irene Wiestner. There were no residents in attendance.

Supervisor Snow, Jr. welcomed Councilors Ingerson and Wiestner to the Town Board. He then explained the Town Board is comprised of five voting members and he, as Supervisor, has no more authority than any other member of the Board. The Board makes decisions and adopts policies and the Supervisor is tasked with seeing those things through. The Town Supervisor does not run the Town, the Town Board does as the governing body for the Town of Granby. We do not have an Executive Branch of Government. The Town Board acts as the Legislative and sometimes the Executive Branch. Granby only consists of the Town Board and the Judges, which are separate from the Board. There are also multiple departments. The Town Clerk and Highway Department the Town Board does not oversee. They are duly Elected Officials and are supervised by the voters. There are multiple departments the Board does oversee.
