## CALL TO ORDER

Supervisor Snow, Jr. called the meeting to order at 6:03 P.M. Present for the **roll call** were Supervisor John Snow, Jr., Councilors Rodney DeLong, Sandra Farrands, Marianne Ingerson and Irene Wiestner. Highway Superintendent Dan Duncan, Planning Board Chairperson Jane Crego and members of the Planning Board were also present. There were three residents in attendance.

### **MOTIONS AND RESOLUTIONS**

Councilor DeLong made a motion, seconded by Councilor Ingerson to approve the Peace Officer contract with the Town of Vienna, all were in favor, none opposed.

Councilor Wiestner made a motion, seconded by Councilor Ingerson to authorize the Supervisor to apply for County ARPA funds, all were in favor, none opposed.

Supervisor Snow, Jr. made a motion, seconded by Councilor DeLong to approve the 2023 Holiday calendar, all were in favor, none opposed.

Supervisor Snow, Jr. said West Eleventh Street is in very bad condition. The line between the City of Fulton and the Town is directly down the middle of the road. Fulton claims the entire road according to the Department of State, even though Granby plows, mows and maintains the road. Fulton is not interested in going in halves with us to pave their portion of the road. Supervisor Snow, Jr. said the County will pave the entire road for \$51,000.00 and another \$5,000.00 to mill it, for a total of \$56,000.00. We would pay for this with \$51,000.00 of ARPA funds with the intent that Granby would claim the road and it will be added into our State Aid formula.

Supervisor Snow, Jr. made a motion, seconded by Councilor DeLong to accept a bid from the County to pave West Eleventh Street in the amount of \$56,000.00, a roll call vote was taken;
