PUBLIC HEARING

Deputy Supervisor Crego called the Public Hearing for Local Law 1-2023, increasing the term of office for the Town Supervisor of the Town of Granby from two (2) years to four (4) years. Present were Deputy Supervisor Jane Crego, Councilors Rodney DeLong, Sandra Farrands, Marianne Ingerson and Irene Wiestner. Highway Superintendent Duncan was also present. There were no residents in attendance.

Deputy Supervisor Crego read the Local Law in full. There were no comments. The Public Hearing was held open.

CALL TO ORDER

Deputy Supervisor Jane Crego called the meeting to order at 6:03 P.M. Present for the **roll call** were Deputy Supervisor Jane Crego, Councilors Rodney DeLong, Sandra Farrands, Marianne Ingerson and Irene Wiestner. Supervisor John Snow, Jr. was not present. Highway Superintendent Dan Duncan was also present. There were no residents or guests in attendance.

The Board spent some time auditing the Court's financial records. They need additional information to finish the audit.

With no comments, Deputy Supervisor Crego closed the Public Hearing at 6:37 P.M.

Councilor DeLong made a motion, seconded by Councilor Ingerson to hire a person to be on the Town payroll to clean, per a job description set up by the Town Board, Councilor Wiestner was in favor, Councilor Farrands abstained.

Councilor Ingerson made a motion, seconded by Councilor DeLong to approve the budget amendment as proposed by Budget Officer Snow, Jr., all were in favor, none opposed,

Councilor Ingerson made a motion, seconded by Councilor Wiestner to appoint Leo Boylan and Erin Brewster to the Board of Assessment Review, all were in favor, none opposed.

Councilor Ingerson made a motion, seconded by Councilor Wiestner to hold the March 2023 work session on March 29th at 6:00 P.M. instead of March 22nd, all were in favor, none opposed.

Deputy Supervisor Crego reminded the Board that registrations for the Tug Hill Commission training are due now in order to get the reduced rates.

There will be a special meeting on March 1st, 2023 at 6:00 P.M. to award the bids for the Town Hall project.

The Town Clerk reported that Fairway Billiards has submitted an amended application for their liquor license stating he cannot have any outside entertainment and his hours of operation are 6:00 A.M. to 8:00 P.M. and special events until 11:00 P.M. Kristen's Kitchen at Battle Island has notified the Town that she is renewing her liquor license.

Councilor Wiestner made a motion, seconded by Councilor DeLong to pay the Town bills as audited on Abstracts 4 and 4P, all were in favor, none opposed.
