CALL TO ORDER

Councilor Ingerson made a motion, seconded by Councilor DeLong to approve the budget modifications as proposed by Supervisor Snow, Jr. as follows, all were in favor, none opposed.

PAYMENT OF TOWN BILLS

Councilor DeLong made a motion, seconded by Councilor Ingerson to pay the Town bills as audited on Abstracts 24 and 24A, all were in favor, none opposed.

Councilor Ingerson made a motion, seconded by Councilor DeLong to schedule the Organizational meeting for 2023 on Wednesday January 11, 2023 at 6:30 P.M., all were in favor, none opposed.

Councilor DeLong made a motion, seconded by Supervisor Snow, Jr. to approve an extended vacation for Court Clerk King, all were in favor, none opposed.

Councilor Ingerson made a motion, seconded by Councilor Wiestner to allow Supervisor Snow, Jr. to dispose of old electronic equipment, all were in favor, none opposed.

There was an informal grievance with a Highway worker regarding a disability claim. After negotiations, the Town settled by paying \$297.50.

Supervisor Snow, Jr. asked Highway Superintendent Duncan if the required yearly Highway inventory list had been filed with the Town Clerk. Mr. Duncan said it had not. Supervisor Snow, Jr. is concerned that the snowplows were not out on several occasions when, in his opinion, the roads were hazardous. Highway Superintendent Duncan said he had checked the roads and didn't feel it was needed.

Supervisor Snow, Jr. reminded Highway Superintendent Duncan that the snow plow was purchased to be on the F350 pickup truck instead of the F250 to avoid a grievance from the Highway Department. Highway Superintendent Duncan stated he only uses the plow to plow the parking lot or in case of an emergency.

Supervisor Snow, Jr. asked that Highway Superintendent Duncan have as many orders delivered as possible instead of going to pick them up due to the price of gas.

Highway Superintendent Duncan said the part time employees have requested a raise and guaranteed show up time of four hours.
