CALL TO ORDER

MOTIONS AND RESOLUTIONS

Resolution #1-2024

Be it resolved, by the Town Board of the Town of Granby, the Official Town Website is to be www.granbyny.com

Councilor Clothier made a motion, seconded by Councilor English to accept **Resolution #5-2024**, all were in favor, none opposed.

Resolution #6-2024

Be it resolved, by the Town Board of the Town of Granby, that each member of the Board of Assessment Review is to be paid \$600.00 after completion of their work, to include: time, travel, and training expenses.

Councilor Ingerson made a motion, seconded by Councilor English to accept **Resolution #6-2024**, all were in favor, none opposed.

Resolution #7-2024

Be it resolved, by the Town Board of the Town of Granby, that Jane Crego be appointed chairperson of the Planning Board until February 15, 2024, and Cheryl Anthony be appointed chairperson of the Zoning Board of Appeals until February 15, 2024.

Councilor Ingerson made a motion, seconded by Councilor Clothier to accept **Resolution #12-2024**, all were in favor, none opposed.

Resolution #13-2024

Be it resolved, by the Town Board of the Town of Granby, that all town financial records for the Town Supervisor, Town Clerk/Tax Collector, and the Justice Court shall be audited by each Town Councilor no later than February 2, 2024, and; that

authorization is given to the Town Supervisor to file the Annual Financial Report in lieu of an annual financial report of the Town Supervisor with the Town Clerk no later than March 30, 2024.

Councilor Ingerson made a motion, seconded by Councilor Farrands to accept **Resolution #13-2024**, all were in favor, none opposed.

Resolution #14-2024

Be it resolved that the Town Board of the Town of Granby, that the amended policies of the Town of Granby, including: Procurement, Computer System Security Breach Notification Policy, Online Banking, Fund Balance, Sexual Harassment Prevention, Asset Management, and the Employee Handbook of the Town of Granby, are reaffirmed as amended.

Councilor Farrands made a motion, seconded by Councilor English to accept **Resolution #14-2024**, all were in favor, none opposed.

Resolution #15-2024

Be it resolved, by the Town Board of the Town of Granby, that John Snow, Jr. is hereby appointed delegate to the Annual Meeting of the Association of Towns.

Resolution #16-2024

Be it resolved, by the Town Board of the Town of Granby, that the Town Supervisor, or his designee, shall be granted the powers and duties of administration and supervisions of Town Special Improvement Districts.

Resolution #17-2024

Whereas, Public Officer Law §11(2) provides that in lieu of any individual undertaking, as required by law, the Town Board may approve the procurement of a blanket undertaking from any duly authorized corporate surety covering the officers, clerks, and employees of the Town of Granby in order to indemnify the Town against losses caused by the failure of the officers or employees to faithfully perform their duties by their fraudulent or dishonest acts, and Whereas The Town Board of the Town of Granby determines that it is more beneficial and economical to provide the undertakings by a

blanketed bond; It is, therefore, resolved, that all officers and or employees of the Town of Granby will be covered by a blanket policy in the amount of \$100,000 per employee, expecting the additional \$150,000 for the Town Supervisor and additional \$800,000 for the Town Clerk/Tax Collector.

Councilor Ingerson made a motion, seconded by Councilor English to accept **Resolution #17-2024**, all were in favor, none opposed.

Be it resolved, by the Town Board of the Town of Granby, pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows: GENERAL REPAIRS. The sum of \$50,000 shall be set aside to be expended for primary work and general repairs upon 62 miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or renewals thereof. This AGREEMENT expires on May 15, 2024, or after the adoption of a subsequent agreement, whichever occurs first.
